 - Google search: Contract or Temporary Staffing | Part Time Flexible Remote
- Networking / word-of-mouth referrals
 - Associations, former colleagues, clubs, neighbors, friends, place of worship, gym
 - Good for freelance work or building a small business
- Thought leadership
 - Blogs, articles, public speaking
 - Best for establishing yourself as a consultant

- Choose to be a sole proprietor, LLC or S-Corp
- Host your URL (GoDaddy, BlueHost)
- Select a website builder and website host (GoDaddy, Wix, Weebly, Squarespace)
- Get business cards (VistaPrint)
- Create a branded LinkedIn profile
- ► Host your email and hard drive (Office 365)
- Hire an accountant
- Consider legal support (e.g. LegalZoom or LegalShield)




